Dr. Lester called the meeting of The Villages Charter School, Inc. to order at 4:00 p.m. on April 29, 2021. Dr. Lester announced a quorum of the Directors was present and that the meeting could proceed.

**STUDENT DISMISSAL APPEAL #1:** The parent was present for the appeal and spoke to the board concerning the appeal. Dr. McDaniel recommended we deny the student dismissal appeal #1.

**UPON A MOTION** by Mr. Stephens and seconded by Ms. Francis and with the unanimous consent of all Board members present, the Board denied the appeal.

**STUDENT DISMISSAL APPEAL #2:** The parent was present and spoke to the board concerning the dismissal. Dr. McDaniel recommended we deny the student dismissal appeal #2.

**UPON A MOTION** by Ms. Francis and seconded by Mr. Stephens and with the unanimous consent of all Board members present, the Board denied the appeal.

#### **CONSENT ITEM**

Dr. Lester presented the minutes of the regular meeting and **UPON A MOTION** made by Ms. Wiechens and seconded by Ms. Francis and the unanimous consent of all Board members present, the Board approved the minutes of the February 25, 2021 meeting.

# **INFORMATION REPORTS**

# **February**

**FINANCIAL REPORT**: The Villages made no advances to the Charter School in February. There were no contributions recognized in February. The Consolidated Statement of Revenue and Expenditures shows a net loss of \$769,153 for the month of February and a year-to-date net income of \$741,175 at February 28, 2021.

#### Donations/Miscellaneous Revenue:

The charter school received \$5,000 from Engineered Floors for the Dollars for Knowledge program.

#### Athletics:

The Villages made no contributions to Athletics for the month of February. The Athletics Department had a net loss of \$44,652 for the month of February and a year to date net income of \$114,874 before Athletics staff salaries and benefits and a year to date net loss of \$140,774 after salaries and benefits.

### Consolidated Entity/Entire Charter School:

At February 28, 2021, the total expenditures for the Charter School as a whole were under budget by 12.7%; therefore reducing the amount of Villages contributions needed.

# March

**FINANCIAL REPORT**: The Villages advanced \$775,000 to the Charter School in March. There were no contributions recognized in March. The Consolidated Statement of Revenue and Expenditures shows a net loss of \$777,548 for the month of March and a year-to-date net loss of \$36,373 at March 31, 2021.

### Donations/Miscellaneous Revenue:

There were no significant donations received by the charter school in March.

#### Athletics:

The Villages made no contributions to Athletics for the month of March. The Athletics Department had a net income of \$22,778 for the month of March and a year to date net income of \$137,652 before Athletics staff salaries and benefits and a year to date net loss of \$149,952 after salaries and benefits.

#### Consolidated Entity/Entire Charter School:

At March 31, 2021, the total expenditures for the Charter School as a whole were under budget by 10.4%; therefore reducing the amount of Villages contributions needed.

**ENROLLMENT UPDATE:** Dr. McDaniel explained to the board that we are currently accepting applications for next school year. We have received close to 600 new applications for the 2021-2022 school year.

## **OLD BUSINESS**

**SRO AGREEMENT EXTENSION:** Dr. McDaniel presented to the Board the SRO Agreement Extension. This extends the 2020-2021 agreement from July 1, 2021 through September 30, 2021.

**UPON A MOTION** by Ms. Wiechens and seconded by Mr. Stephens and the unanimous consent of all Board members present, the Board approved the SRO Agreement Extension.

**2021-2022 SRO AGREEMENT:** Dr. McDaniel presented to the Board the 2021-2022 SRO Agreement. The agreement starts October 1, 2021 through September 30, 2022.

**UPON A MOTION** by Ms. Francis and seconded by Mr. Stephens and the unanimous consent of all Board members present, the Board approved the 2021-2022 SRO Agreement.

**2021-2022 UNIFORM POLICY:** Dr. McDaniel presented to the Board the 2021-2022 Uniform Policy. There are no changes from last year's policy.

**UPON A MOTION** by Ms. Francis and seconded by Ms. Wiechens and the unanimous consent of all Board members present, the Board approved the 2021-2022 Uniform Policy.

## **NEW BUSINESS**

**ACCOUNTABILITY REPORT:** Dr. McDaniel presented to the Board the 2019-2020 Accountability Report.

**UPON A MOTION** by Ms. Francis and seconded by Dr. Theeck and the unanimous consent of all Board members present, the Board approved the 2019-2020 Accountability Report.
