#### **INFORMATION REPORTS**

## <u>November</u>

**FINANCIAL REPORT**: The Villages advanced (checks written) \$1,849,300 (\$899,300 for the Middleton campus) to the charter school in November. There were \$1,243,598 of Villages contributions recognized in November The Consolidated Statement of Revenue and Expenditures shows a net loss of \$812,266 for the month of November and a year to date net loss of \$2,727,095 at November 30, 2022.

#### Donations/Miscellaneous Revenue:

There were no significant donations received in November.

#### Athletics:

The Villages made no contribution to Athletics for the month of November The Athletics Department had a net loss of \$1,801 for the month of November and a year to date net income of \$218,984 before Athletics staff salaries and benefits and a net income of \$94,930 after salaries/benefits.

## Consolidated Entity/Entire Charter School:

At November 30, 2022, the total expenditures for the Charter School as a whole were under budget by 6.0%; therefore reducing the amount of Villages contributions needed.

#### <u>December</u>

**FINANCIAL REPORT**: The Villages advanced \$1,248,000 to the charter school in December. The Villages contributed \$2,155,724 to the charter school in December. The Consolidated Statement of Revenue and Expenditures shows a net loss of \$516,652 for the month of December and a year to date net loss of \$3,243,746 at December 31, 2022.

# Donations/Miscellaneous Revenue:

There were no significant donations received in December.

#### Athletics:

The Villages made no contribution to Athletics for the month of December. The Athletics Department had a net loss of \$90,588 for the month of December and a year to date net income of \$128,397 before Athletics staff salaries and benefits and a net loss of \$20,468 after salaries/benefits.

### Consolidated Entity/Entire Charter School:

At December 31, 2022, the total expenditures for the Charter School as a whole were under budget by 9.5%; therefore reducing the amount of Villages contributions needed.

**ENROLLMENT UPDATE:** Dr. McDaniel explained to the board that we will be starting open enrollment for the 23-24 school year in February 2023.

**CONSTRUCTION UPDATE:** Ms. Wiechens explained that all buildings are currently on schedule.

**SCHOOL & CAMPUS REPORTS**: Each building principal gave a brief update on recent and upcoming events.

**VHS ALUMNI & BSF REPORT:** Mr. Murphy gave an overview of the VHS Graduates and the BSF results since 2006.
