INFORMATION REPORTS

FINANCIAL REPORT: The Villages advanced (checks written) \$640,000 to the charter school and made no contributions in September. The Consolidated Statement of Revenue and Expenditures shows a net loss of \$914,115 for the month of September and a year to date bet loss of \$3,185,231 at September 30, 2022.

Donations/Miscellaneous Revenue:

There were no significant donations received in September.

Athletics:

The Villages made no contribution to Athletics for the month of September. The Athletics Department had a net income of \$6,172 for the month of September and a year to date net income of \$258,947 before Athletics staff salaries and benefits and a net income of \$174,365 after salaries/benefits.

Consolidated Entity/Entire Charter School:

At September 30, 2022, the total expenditures for the Charter School as a whole were under budget by 11.2%; therefore reducing the amount of Villages contributions needed.

ENROLLMENT UPDATE: Dr. McDaniel explained to the board that we currently have no students on the waiting list. We are going to start enrollment for the 23-24 school year earlier than in the past to get ready for the new campus.

CONSTRUCTION UPDATE: Dr. McDaniel explained that we are on schedule to finish on time.

VHS ACADAMIES: Dr. McDaniel explained to the Board the history, current status, and future of VHS Academies.

SCHOOL & CAMPUS REPORTS: Each building principal gave a brief update on recent and upcoming events.
