**FINANCIAL REPORT**: The charter school received \$1,927,724 in Villages contributions in September mainly for the Middleton campus and former high school building remodel at Buffalo Ridge. The Consolidated Statement of Revenue and Expenditures shows a net loss of \$879,787 (including Athletics net loss of \$45,632) for the month of September and a year to date net loss of \$3,299,425 (including Athletics net income of \$315,731) at 9/30/23.

Donations/Miscellaneous Revenue:

The Charter school received OEC furniture rebates in the amount of \$124,554 in September.
