#### **INFORMATION REPORTS**

**FINANCIAL REPORT**: The Villages advanced (checks written) \$2,600,000 to the charter school and made no contributions in August. The Consolidated Statement of Revenue and Expenditures shows a net loss of \$1,109,737 for the month of August and a year to date bet loss of \$2,271,116 at August 31, 2022.

Donations/Miscellaneous Revenue:

There were no significant donations received in August.

#### Athletics:

The Villages made no contribution to Athletics for the month of August. The Athletics Department had a net income of \$24,086 for the month of August and a year to date net income of \$252,775 before Athletics staff salaries and benefits and a net income of \$196,387 after salaries/benefits.

Consolidated Entity/Entire Charter School:

At August 31, 2022, the total expenditures for the Charter School as a whole were under budget by 15.2%; therefore reducing the amount of Villages contributions needed.

**ENROLLMENT UPDATE:** Dr. McDaniel explained to the board that we currently have no students on the waiting list. We are going to start enrollment for the 23-24 school year earlier than in the past to get ready for the new campus.

**CONSTRUCTION UPDATE:** Dr. McDaniel explained that we are on schedule to finish on time.

VCS ENROLLMENT POLICY 101: Dr. McDaniel explained to the Board how the VCS Enrollment Policy was created.
