

#### **DIABETES PARENT HISTORY FORM**

• Complete information and all questions, giving details

#### **EMERGENCY ACTION PLAN**

- Complete top box that contains contact names and phone numbers
- · Sign the back of the form in the top box
- This form may be updated annually for a total of 3 school years

#### **DIABETES SCHOOL ORDERS**

- Your child's Health Care Provider (HCP) will provide "School Orders" (also called a DMMP) to you. Please provide those to the VCMS school nurse at the beginning of the school year
- At each follow up appointment with your student's HCP, if orders are changed or modified, your child's HCP will provide updated school orders
- Your child's HCP may fax those orders to the school: Attention: Joy - VCMS School Nurse. Fax: 352-259-6809. They can also be emailed to Joy.Shumate@tvcs. org. Otherwise, you or your child may bring the orders to the clinic nurse
- New orders required each school year and when there are changes in orders

### INDIVIDUALIZED HEALTH CARE PLAN

- · Complete top section, sign and date
- The school nurse will develop a care plan for your child's medical needs based on your input, your child's input and HCP's order
- This form may be updated annually for a total of 3 years

## TVCS CONSENT FORM & STUDENT MEDICATION ADMINISTRATION RECORD

- Complete top section, sign and date. This form is for the Glucagon Kit
- A Glucagon Kit or Baqsimi Nasal Glucagon must be available during school hours. The student may keep the Glucagon Kit or Baqsimi in his/her supply bag but it must be kept in the clinic during the school day
- · A new form is required each school year

- Once at the Middle School site, click on "Clinic" on the left column

### **OTHER CONSIDERATIONS**

- Snacks to be brought from home: include protein snacks (peanut butter or cheese crackers) and fast acting sugar (like smarties or glucose tablets)
- Student must always have fast acting sugar and a protein snack in their backpack in case of an emergency
- Students on pumps should have 1 extra pump set available at school
- In case of pump failure, an insulin pen may be kept at school or in the student's supply bag
- Student will have a space of their own in the clinic to keep extra supplies
- Please supply Ketone strips to be kept in the clinic if your child's HCP requires Ketone testing for high blood glucose
