NARCOTIC, CONTROLLED SUBSTANCE OR ANY SUBSTANCE WHEN  
USED FOR CHEMICAL INTOXICATION OTHER THAN ALCOHOL  
POSSESSION, USE, OR SALE OF ANY FIREARMS ON CAMPUS  
POSSESSION, USE OF, OR THREAT WITH A WEAPON  
BATTERY OR AGGRAVATED BATTERY ON SCHOOL PERSONNEL  
BOMB THREAT  
RAPE, ATTEMPTED RAPE, OR SEXUAL BATTERY  
ARSON/ATTEMPTED ARSON  
HOMICIDE, MURDER, MANSLAUGHTER  
ARMED ROBBERY  
AGGRAVATED BATTERY  
KIDNAPPING/ABDUCTION
