SUBJECT: Designation of 2024-2025 Schools of Excellence

The State Board of Education designated the list of 2024-2025 Schools of Excellence on September 24, 2025. Section 1003.631, Florida Statutes, requires the State Board to designate a school as a School of Excellence if the school's percentage of possible points earned in its school grade calculation is in the 80th percentile or higher for schools comprised of the same grade groupings (elementary, middle, high and combination) for at least two of the last three school years.

This program was created by the Florida Legislature in 2017. Schools that initially qualify for the designation retain their designation as a School of Excellence for up to three years, at the end of which they may renew the designation. School districts with a 2024-2025 School of Excellence are listed on page two of this memo. The list of schools is posted at <https://www.fldoe.org/accountability/accountability-reporting/school-grades/>.

For 2024-2025, 744 schools were designated as a School of Excellence across 49 school districts. Of these schools, 386 maintained their designation, 304 renewed their designation and 54 were newly designated.

A School of Excellence has the following administrative flexibilities outlined in law:

- exemption from any provision of law or rule that expressly requires a minimum period of daily or weekly instruction in reading;
- principal autonomy as provided under section 1012.28(8), Florida Statutes;
- instructional personnel may substitute one school year of employment at a School of Excellence for 20 inservice points, up to 60 inservice points total in a five-year cycle, toward the renewal of a professional educator certificate;
- exemption from compliance with school district policies or procedures establishing times for the start and end of the school day; and
- calculation of class size compliance based on the average number of students at the school level.
